- o Private Passenger is defined as a four wheel auto of the private passenger or station wagon type. A pickup, panel truck or van not used for business is rated as a PPT.
- Business Use: vehicles used principally in the operation of the business (service, retail, commercial use). If the vehicle is registered to a corporation classify it as Business use unless there is detailed information indicating that the vehicle is not used for business purposes.
- Commuting Use: vehicles are used to transport individuals to/from their place of work and are normally parked during the entire work period and not otherwise used in business – this is not considered Business use. If a vehicle is used to travel to/from work but also used routinely in the business, it is considered Business use.
- o Determine the use of SUV's, light trucks, panel vans and mini-vans in order to properly classify the vehicle. These vehicles can be rated as Light Trucks or Private Passenger vehicles.

(GVW) and GCW Defined

- Gross vehicle weight is the maximum loaded weight as specified by the manufacturer for which the manufacturer designed a single vehicle. (GCW): If a vehicle is used with a trailer (i.e. a fifth-wheel vehicle [truck-tractor]), then the GCW shall be utilized for classification purposes.
- Gross combination weight is the maximum loaded weight as specified by the
 manufacturer for a combination truck-tractor and semi-trailer or trailer for which the
 manufacturer designed a truck-tractor. The GCW applies to the power unit. The trailer or
 semitrailer should be separately classified. The GCW is obtained by adding the GVW of
 the tractor and the weight of the heaviest semitrailer and or trailer the tractor can pull.
